



BEHAVIOR LOG HOURS MUST BE ENTERED DIRECTLY INTO THE EMBEDDED BEHAVIOR LOG WITHIN THE ONLINE APPLICATION.

The **CBCC-KA BEHAVIOR LOG** must document at least 300 hours within the last 3 years of canine behavior consulting dealing with issues such as: fear, phobias, compulsive behavior, anxiety and aggression. Please see the CBCC-KA Candidate Handbook for the complete Behavior Log eligible hours guidelines. Behavior hours can be accrued in a paid or voluntary position. Behavior hours cannot be accrued by working with your own dog.

All Behavior Log hours MUST be entered directly into the online application. Please do not use acronyms. You may summarize your Behavior Log hours to a **MAXIMUM** of one client for one month per row.

Individual Hours:

MINIMUM of 225 hours of behavior-consulting that include behavior modification training with an individual dog or a client and their dog in the areas of fear, phobias, compulsive behaviors, anxiety, or aggressive behavior.

Group Hours:

MAXIMUM of 75 hours of experience through instructing a specialized group dog training class where the curriculum is dedicated to addressing fear, phobias, anxiety, or aggressive behavior. Group hours cannot be accrued during basic obedience group class instruction.

NOTE: Individual and Group Hours reflect different activities and **CANNOT** be listed in the same row.

The following information is required for your Behavior Log:

- **Month/Year** (select from drop down calendar; select any day as it is not recorded)
- **Client Name** (client last name is sufficient)
- **# of Sessions in Month**
- **Issue** (fear, phobias, compulsive behavior, anxiety, aggression or similar)
- **Individual Hours** (number of hours accrued for the client in the month; if no individual hours, enter 0)
- **Group Hours** (number of hours accrued for the client in the month; if no group hours, enter 0)
